IMPORTANT VOTING INFORMATION:

To be eligible to vote in this election, you must be at least 18 years of age, be a citizen of the United States, be a resident of the Town of Westcliffe, and have resided in this state for twenty-two days immediately preceding the election and be a registered voter.

The Mail Ballot Drop off locations for ballots are Westcliffe Town Hall, 1000 Main St, Westcliffe, CO. the Town Hall is open for election business 8 a.m. to 5 p.m. Monday through Friday March 11th through April 1st, and from 7:00 a.m. to 7:00 p.m. on Election Day April 2, 2024.

All voted ballots must be received by the Westcliffe Town Clerk by 7:00 p.m. on Election Day. The outside Mail Ballot Drop-Off box is in the back of the building and will close at 6:00 p.m. on Tuesday, April 2nd, Election Day.
